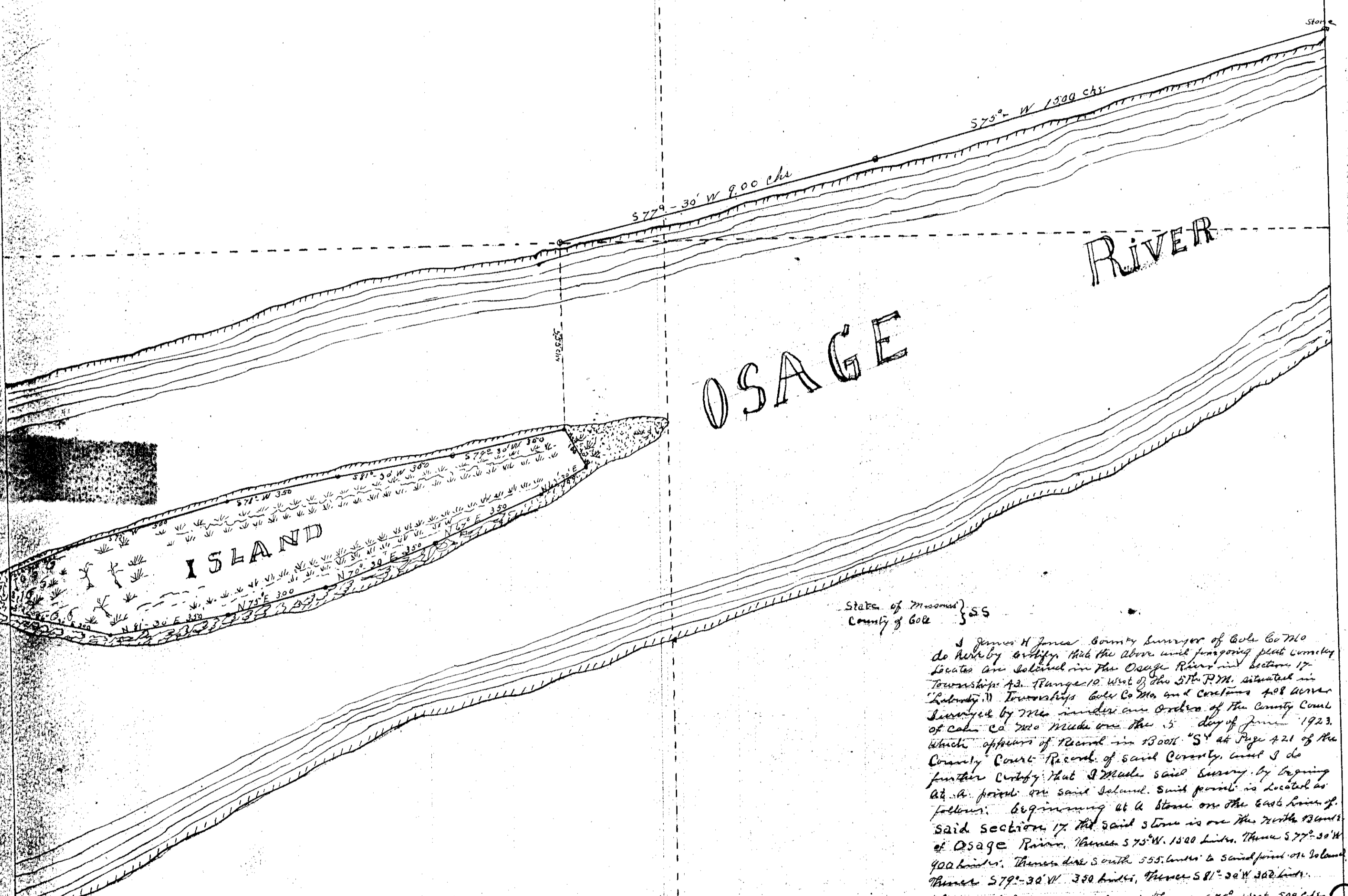

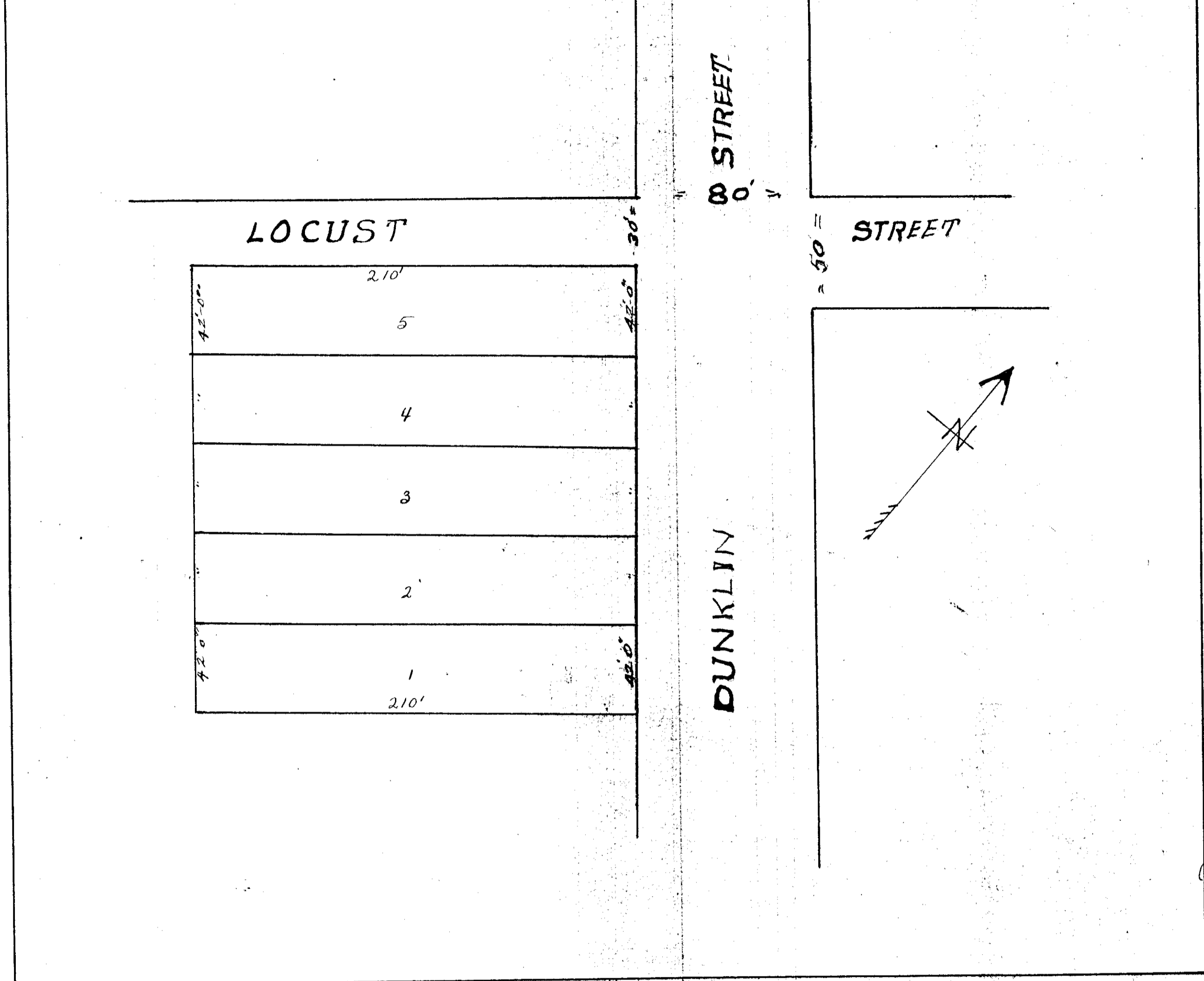

Mo and containing 408 acres surveyed by the undersigned and ordered by the County Court of Cole Co. Mo made on the 5th day of June 1923 which appears of record in Book 54 at Page 421 of the County Court Record of said County, and I do further certify that I made said survey by beginning at a point on said Island, said point is located as follows: Beginning at a stone on the east corner of said section 10. The said stone is on the north shore of Osage River. Thence S 75° W 1500 Links, Thence S 77° 30' W 900 Links, Thence S 79° 30' W 1200 Links, Thence S 81° 30' W 300 Links, Thence S 78° W 300 Links, Thence S 75° West 500 chs. Thence S 62° 30' W 200 Links, Thence S 700 chs. Thence S 81° 30' E 300 Links, Thence N 81° 30' E 200 Links, Thence N 75° E 200 Links, Thence N 78° 30' E 300 Links, Thence N 87° E 350 chs. Thence N 65° 30' E 150 chs. Thence N 27° 30' W 100 chs. & from of beginning.
