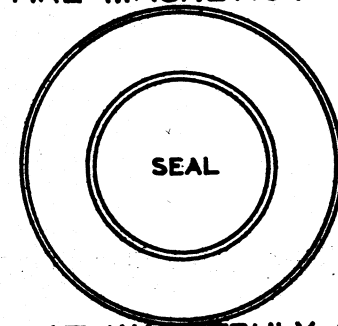

SURVEYOR'S CERTIFICATE

KIESLING DO HEREBY CERTIFY THIS PLAT TO BE A CORRECT RECORD OF A SURVEY MADE BY ME DURING THE MONTH OF DECEMBER, 1968, OF A TRACT OF LAND BEING A PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 16, TOWNSHIP 44 NORTH, RANGE 11 WEST, COLE COUNTY, MISSOURI AND MORE PARTICULARLY DESCRIBED AS FOLLOWS: FROM THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 16; THENCE WESTERLY, ALONG THE QUARTER SECTION LINE, 318.0 FEET; THENCE S 4° 30' E, 503.0 FEET TO THE NORTHERLY LINE OF BUSINESS ROUTE 50-63; THENCE N 71° 18' W, ALONG THE NORTHERLY LINE OF BUSINESS ROUTE 50-63, 150.0 FEET, TO THE POINT OF BEGINNING FOR THIS DESCRIPTION; THENCE CONTINUING N 71° 18' W ALONG SAID NORTHERLY LINE, 322.0 FEET; THENCE N 4° 20' W, 137.75 FEET; THENCE S 83° 32' E, 300.92 FEET; THENCE S 4° 30' E, 207.18 FEET TO THE POINT OF BEGINNING. BEARINGS ARE MAGNETIC.
