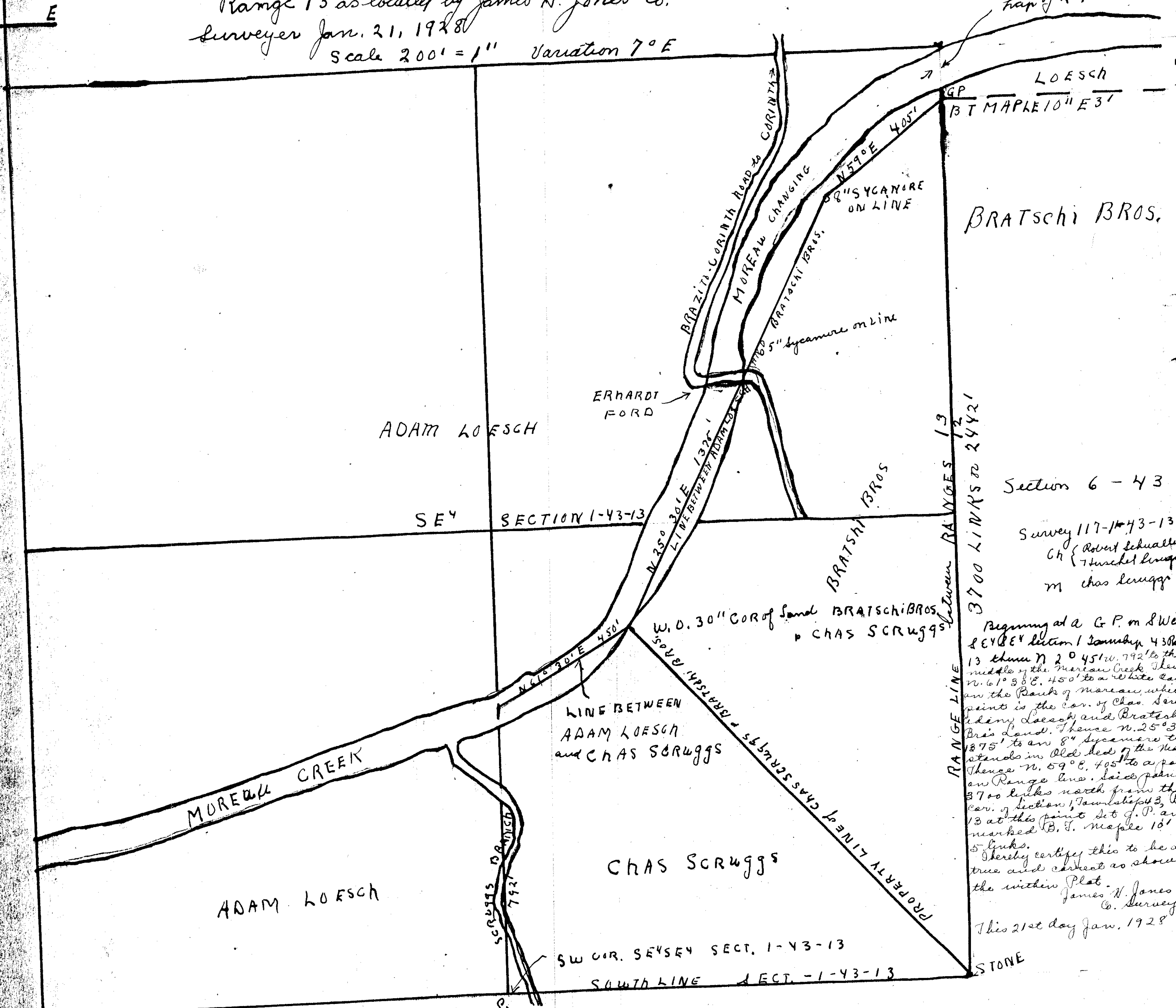


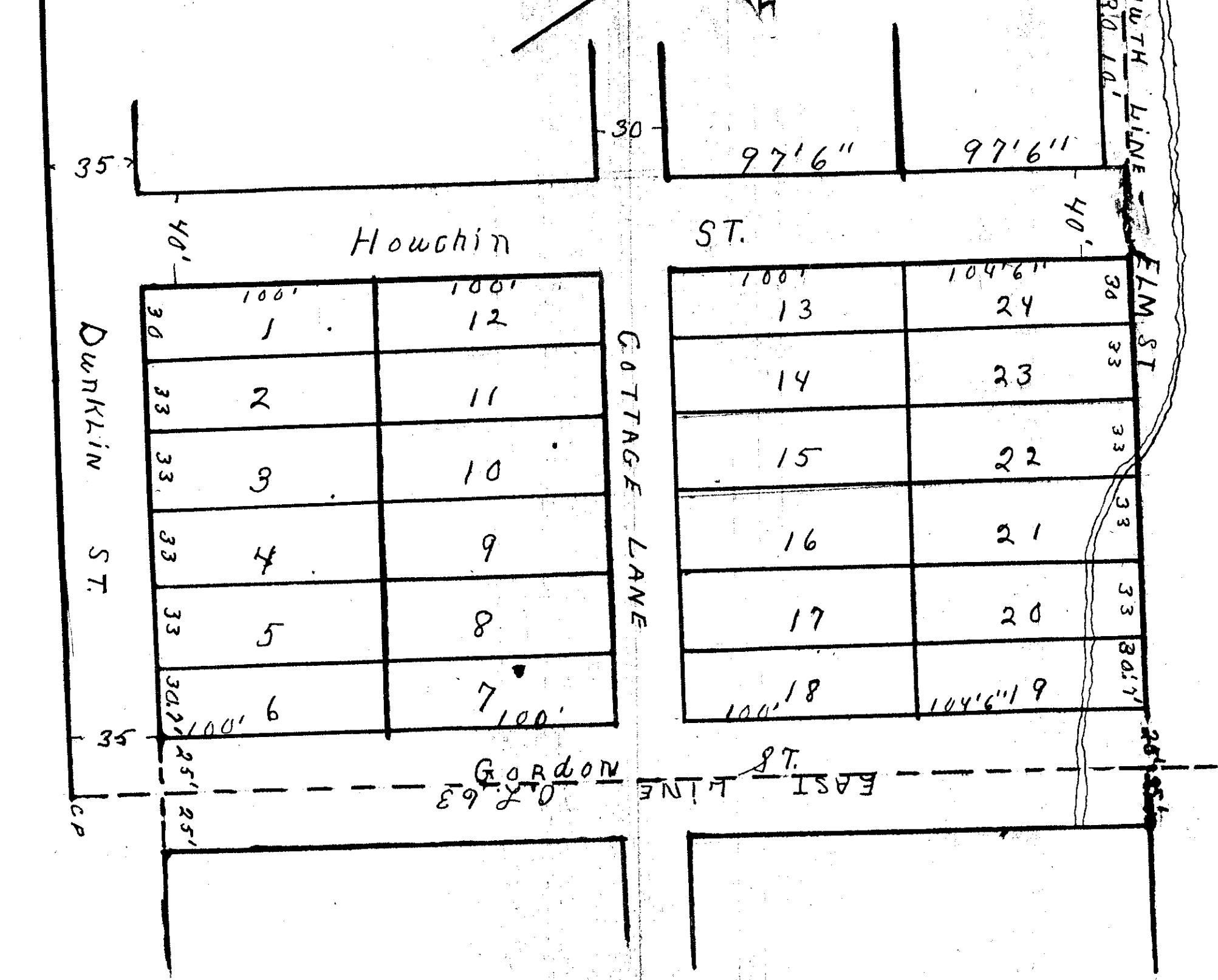
PLAT SHOWING DIVISION LINE

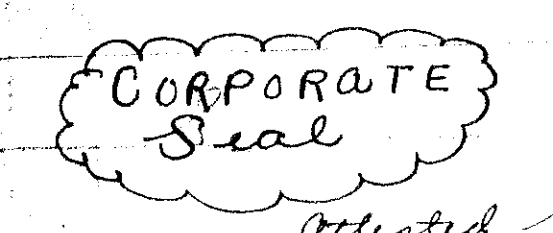


EASTLAND ADD.
