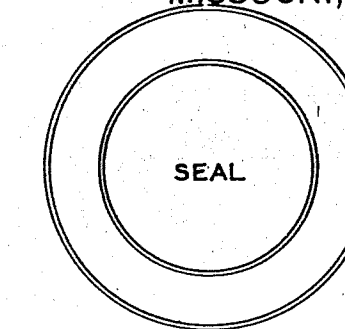


SURVEYORS CERTIFICATE

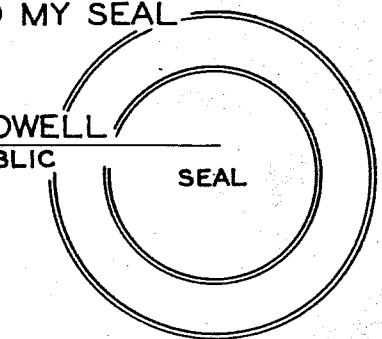
