

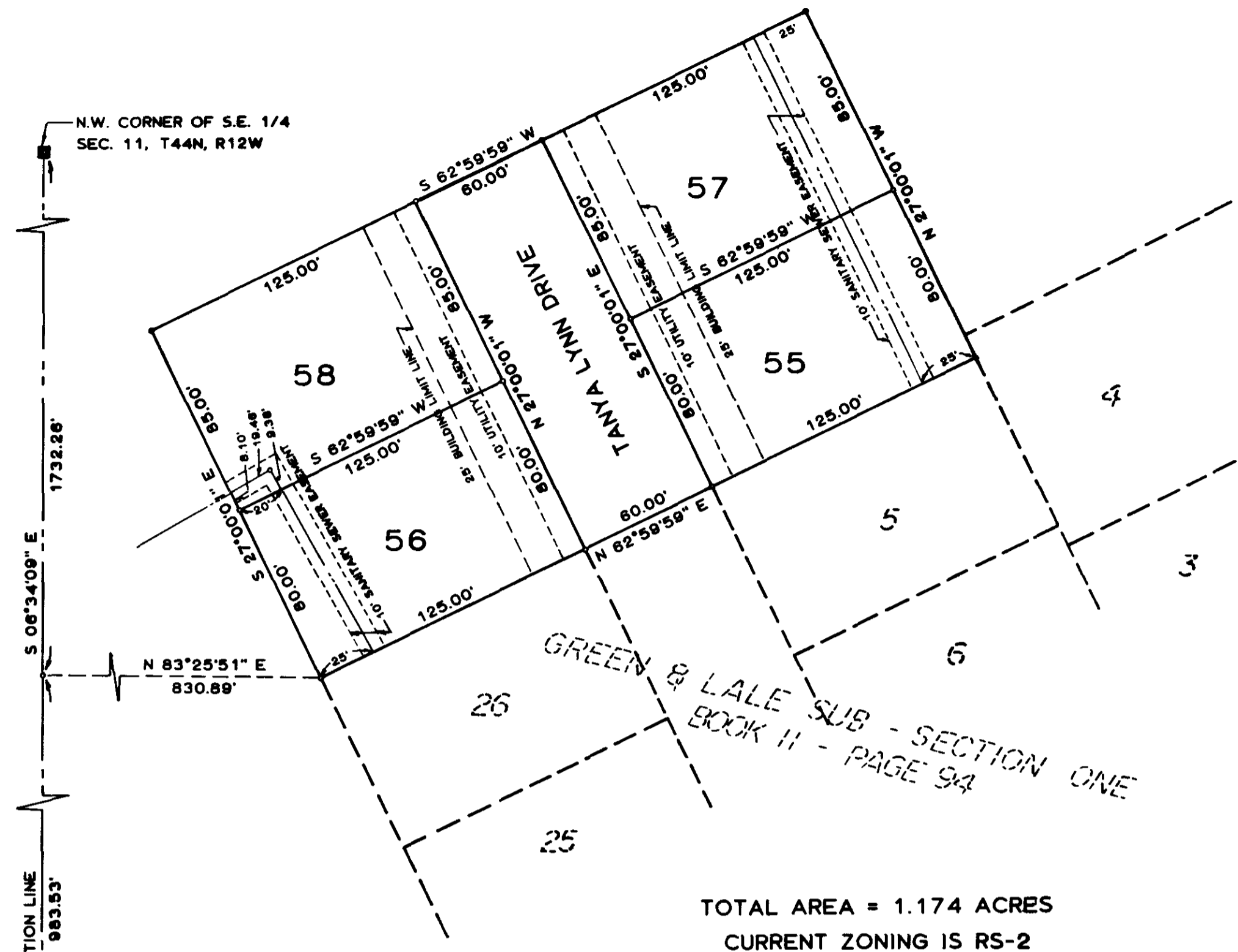
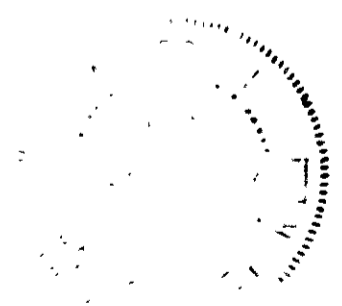
LOCATION SKETCH
