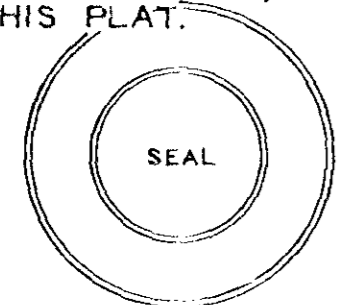


SURVEYORS CERTIFICATE

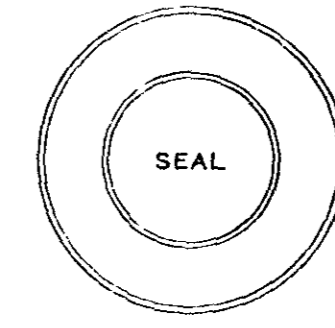
