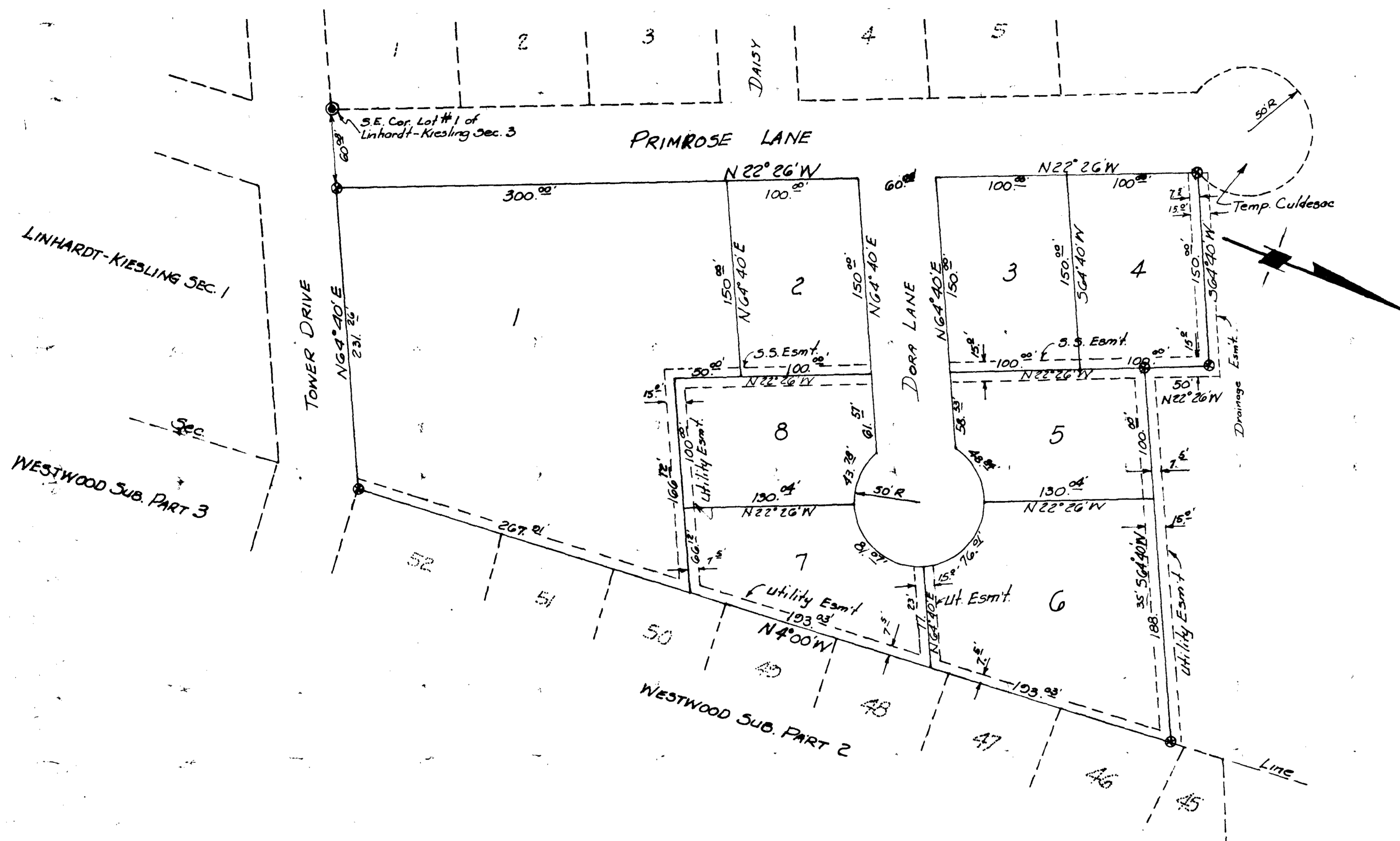


LINHARDT-KIESLING SEC. 3
