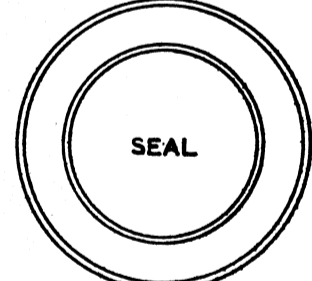


SURVEYORS CERTIFICATE
